Poinsettias – are generally looking good, with fewer whitefly issues than 2012, at least so far!

Hunter Flies

When visiting poinsettia growers, I have been seeing adult *hunter flies*, on yellow sticky cards and perching on leaves. Adults attack primarily fungus gnats and shore flies and perch on a leaf to wait for their prey. Don't confuse these beneficial flies with shore flies. Hunter flies have clear shiny wings with no spots and are about twice the size of shore flies. The soil dwelling larvae are also predaceous, feeding of the soft bodied fungus gnat larvae.

Weeds – Now is a good time to clean up your greenhouse if you are not growing poinsettia and are finished shipping mums. See Greenhouse Weed Control for options.

There is now a pre-emergence herbicide (Marengo®) labeled for use on greenhouse floors in **empty greenhouses.** You must wait 24 hours before introducing plant material into the empty greenhouse after applying this material.

Mainspring (cyantraniliprole) from Syngenta is now registered in Connecticut, which may help address some of the needs for insecticide rotations. It is in the IRAC Group 28, which is a new mode of action for greenhouse use. Mainspring is labeled for caterpillars, leaf miners, thrips, and whiteflies as a foliar spray with translaminar and systemic activity. It is labeled as a drench for aphids and *Bemisia* whiteflies. It is best used as a preventive and with long lasting control (~6 weeks) as a drench.
